ORDER

vide this office proceedings read as 6th paper above Online General Transfer 2013-14 have been ordered and was published in "www.vhse transfer.in". The online procedures were completed in accordance with the Government Orders and Government directions read as 1 to 4 and final orders were issued complied with the judgement referred to in 7th above.

Several petitions were received in this regard from teachers who were transferred to distant schools and several original application were filed in the Hon'ble Kerala Administrative Tribunal by those who got transfer seeking permission to join in the new station. In the circumstances, a committee has been constituted to examine the grievances of the teachers and suggest suitable remedies. After having examine the petitions in detail the committee recommended certain modifications to the online general transfer.

In the circumstance, sanction is hereby accorded to uphold the proceedings No. E1/19625/11 dated 04.07.2013 with the following modifications/additions.
